1. Visit www.bknmu.edu.in (Ph.D. tab)
2. Download Enlistment form and Registration form, fill them properly. Submit hard copies of enlistment and Registration forms along with one copy of your research proposal to the Ph.D. Section.
3. Pay Rs.1000/- as Admission/Enlistment Form and Processing fee and Rs.1500/- as registration fee. You have to collect the fee memo from the Ph.D. Section for Registration fee.
4. Submit both forms along with details of your guide, NOC (if you are in-service), research proposal, all annexures etc to the Ph.D. Section.
5. Collect fee memo from Ph.D. Section and pay Sem.-I fee.
6. Your guide allocation letter are sent to your guide and the concern students.
7. The whole process is to be completed between **31/01/2026 to 07/02/2026.**
8. Students from other University (other than BKNMU) must obtain a PEC, please refer to the circular for the procedure.

Limit on Number of Students for guidance

A Research supervisor/Co-supervisor who is a Professor, at any given point of time, cannot guide more than Eight (8) Ph.D. scholars, an Associate Professor as Research Supervisor can guide up to a maximum of six (6) Ph.D. scholars and an Assistant Professor as Research Supervisor can guide up to a maximum of four (4) Ph.D. scholars. The Scholar who is a Research Assistant/Research Associate/JRF/SRF/WoS/Project Fellow/Project Assistant or having any other fellowship and working in Research Project of Research Supervisor shall be in addition to the above mentioned numbers of respective Ph.D. Guide i.e. they will be considered as supernumerary. In any case, supernumerary seats should not be more than two which includes the international students as well.
