- (2) The Estimate Yearly Consumption of the of Chemicals / Reagents / Glassware & Plastic ware / Lab ware / Specimens / Miscellaneous items / Gases /[Minor laboratory equipment / Instruments (costing not more than Rs. 1.0 lakh)] is expected around Rs.70 Lakhs.
- (3) Submit your offer in Tender form only with the <u>Tender fee of Rs. 5000/-</u> and EMD 3% of expected around Rs.70 Lakhs (Refundable) by D.D. only in favor of "Registrar, Bhakta Kavi Narsinh Mehta University, Junagadh" for each brand. Any other type of form will not be accepted.
- (4) Vendors, after approval for ARC shall have to pay Rs. 10,000/- for each brand and each category to the University as Security deposit against each brand separately, which will be refunded on completion of the contract period without any interest.
